

**AGREED ORDER
AMENDING THE COOK COUNTY CLERK’S EXEMPT LIST**

By agreement of the parties and pursuant to paragraph N of the 1991 Hiring and Exemptions Judgment Entered Upon Consent of Cook County Clerk, the Cook County Clerk’s List of Exempt Positions is amended to add the Director of Communications position. A complete Cook County Clerk’s List of Exempt Positions is attached hereto as Exhibit A.

Every 45 days (starting with the date the position is filled), the Clerk will provide the Plaintiffs and the Compliance Administrator with relevant evidence that the role is being fulfilled in a way that warrants the exemption for the following positions: (1) Director of Recording Operations, (2) Director of Real Estate and Tax Services, and (3) Multimedia Producer/Videographer. For the Multimedia Producer/Videographer position, the Clerk will provide (i) details of the volume of social media posts, (ii) details of the volume of written responses to taxpayer questions, and (iii) confirmation from the employee holding the position of the extent to which the employee is operating autonomously when posting on social media and responding to taxpayer questions.
